ABSTRAK

Instalasi Farmasi Klinik bertugas dalam Pengelolaan obat yaitu dimulai tahap Pemilihan, Perencanaan, Pengadaan, Penerimaan, Penyimpanan, Pendistribusian, Pemusnahan, Pengendalian, Pencatatan dan Pelaporan, Monitoring dan Evaluasi yang diperlukan bagi kegiatan pelayanan kefarmasian. Observasi Pendahuluan menunjukkan permasalahan yang sering terjadi seperti kekosongan stok obat, Penyimpanan obat digudang belum sesuai dengan SOP, dan Pemusnahan obat belum sesuai dengan Permenkes No 34 Tahun 2021. Penelitian ini bertujuan untuk mengetahui Evaluasi Manajemen Pengelolaan Obat di Instalasi Farmasi Klinik X Cilacap. Metode Penelitian ini yaitu Analisis deskriptif dengan menggunakan data kualitatif melalui wawancara mendalam kepada informan disertai melakukan pengamatan langsung (observasi) dalam kegiatan pengelolaan obat. Berdasarkan hasil penelitian tentang Evaluasi Manajemen Pengelolaan Obat Di Instalasi Farmasi Klinik X Cilacap, bahwa manajemen pengelolaan obat di Klinik X Cilacap telah sesuai dengan Permenkes No 34 Tahun 2021 Tentang Standar Pelayanan Kefarmasian Di Klinik, namun dalam setiap manajemen pengelolaan obat di Klinik X Cilacap ada beberapa pengelolaan obat yang belum terdapat SOP dan mempunyai beberapa kendala. Hasil Penelitian menunjukkan bahwa manajemen pengelolaan obat di Klinik X Cilacap belum semua terlaksana dengan baik.

ABSTRACT

The Clinical Pharmacy Installation is in charge of drug management, starting with the Selection, Planning, Procurement, Acceptance, Storage, Distribution, Destruction, Control, Recording and Reporting, Monitoring and Evaluation stages needed for pharmaceutical service activities. Preliminary observations show problems that often occur such as empty drug stocks, drug storage in warehouses not in accordance with SOP, and drug destruction not in accordance with Permenkes No 34 of 2021. This study aims to determine the Evaluation of Drug Management Management in the Pharmacy Installation of Clinical X Cilacap. This research method is descriptive analysis using qualitative data through in-depth interviews with informants accompanied by direct observation (observation) in drug management activities. Based on the results of research on the Evaluation of Drug Management Management at the X Cilacap Clinic Pharmacy Installation, that the management of drug management at the X Cilacap Clinic is in accordance with Permenkes No 34 of 2021 concerning Pharmaceutical Service Standards at the Clinic, however, in every drug management management at the X Cilacap Clinic there are several management of drugs that do not yet have SOPs and have several obstacles. The results of the study showed that not all drug management at Clinic X Cilacap had been carried out properly.
